

# Liability waiver

## Zurich City Triathlon 2023



ZURICH CITY TRIATHLON

Each participant must sign the following liability waiver and hand it in at check-in. This Liability waiver refers exclusively to the Zurich City Triathlon 2023.

### 1. Regulations

As an athlete I am obliged to comply with the regulations of the organiser according to the announcement as well as the official competition regulations of Swiss Triathlon.

### 2. Physical fitness

I affirm that I am physically fit and have trained sufficiently for this competition.

### 3. Insurance

I hereby affirm that I have sufficient insurance coverage for illnesses and accidents.

### 4. Risk

I am aware that there are inherent dangers in participating in a competition and that the risk of serious injury, fatal accidents or even death cannot be 100% excluded.

### 5. Responsibility

I know and agree that during the Zurich City Triathlon and related activities I am solely responsible for my personal belongings as well as the sports equipment.

### 6. Registration data

I acknowledge that my registration data may be made known to third parties through the announcement of rankings and the like.

### 7. Image rights

I transfer image and sound rights for photos, film recordings, interviews etc. to the organiser or the companies or sponsors commissioned in connection with the event - without any claim to remuneration. The data may be used for advertising purposes.

### 8. Liability

I indemnify the organisers, the operators and the volunteers of the Zurich City Triathlon against all liability claims, insofar as these are not covered by legal liability. This includes all direct and indirect

damages as well as all claims that I or my heirs or other entitled third parties may assert due to injuries suffered or in the event of death.

Furthermore, I release all those mentioned in this section from any liability towards third parties, insofar as they suffer damages as a result of my participation in the Zurich City Triathlon.

### 9. Entry fee

I know that if the event cannot take place or can only take place in a modified form due to force majeure or official requirements, there is no right to a refund of the entry fee.

### 10. Participation of minors

For underage participants, the liability waiver must be signed by a custodial person. This is deemed to be the consent of the custodial person that the participation of the minor is authorised.

### 11. COVID-19

I have acknowledged and agree to comply with a COVID-19 protection plan if required by law or by the current situation. I confirm with my signature that I will start completely healthy.
